"The consequence was that research including a substantial percentage of individuals whose research enrollment would have been ethically impermissible otherwise was facilitated by offering additional safeguards through the routine use of an experienced capacity-assessment team that is free of conflicts of interest that research teams might have. The alternative pathways to enrollment that were recommended included surrogate consent by previously assigned DPA, by DPA assigned at the time of the capacity assessment, or by next of kin."

#### ETHICS CONSULT SERVICE

#### CLINICAL RESEARCH ETHICS SERVICE

We provide free consultation on ethical issues related to research design, tissue banking, genetic research results, informed consent, and working with vulnerable patient populations. In particular, we assist clinical investigators in identifying and addressing the ethical challenges that frequently arise when designing or conducting research with human subjects. These include ethical challenges in sampling design; randomized and placebo-controlled studies; participant recruitment and informed consent; return of individual-level research results; community engagement processes; and more.
