These include ethical challenges in sampling design; randomized and placebo-controlled studies; participant recruitment and informed consent; return of individual-level research results; community engagement processes; and more. 





Dr. Rebecca Benson guided us through the opportunities, challenges, and ethical issues of opioid treatment agreements.
